MONTHLY TOWN BOARD MEETING: February 8, 2022.

CALL TO ORDER: 6:30 p.m. in the Civic Center by Roy Bloom, Chair.

ATTENDANCE: Roy Bloom, Chair; Chris Elkins, Supervisor; Jeff Hurula, Supervisor; Diane Gehr, Treasurer; Andy Tuttle, Clerk; Mark Jerome, Public Works Director; 2 members of the public.

MINUTES: Motion by Elkins, second by Hurula to approve the minutes of the January 11, 2022 town board meeting. **CARRIED.**

TREASURER'S REPORT: Gehr reported the following balances are in town accounts: Checking \$401,316.58, Savings \$354.42, Tax savings \$1,280,949.97, and LGIP \$124,926.63.

ROAD REPORT: Jerome reported:

- The crew has been working on Oswald Rd. getting ready things ready for new gravel this summer.
- He talked to a concerned citizen regarding the disrepair of the pavilion floor. The board discussed the problem and agreed to have the town crew tear out the wooden floor and set a gravel base this summer.
- CBS Squared should have the campground plans done early March and sent to shortly after. They are hoping for a June 24th completion date.
- Pre-season campground reservations are way up over last year.

SUPERVISOR REPORT: Bloom received a letter from Bayfield County regarding potential sites for housing. There may be an option by the well house. Roy will let them know we may have some options.

PUBLIC COMMENT: There was no public comment.

OPERATOR/BARTENDER LICENSE: Two applications for licenses were received by the clerk: Amanda Rauch and Haley Matanowski. The clerk recommended issuing licenses. Motion by Hurula, second by Elkins to issue bartender/operator licenses to Amanda Rauch and Haley Matanowski.

CARRIED.

MILL POND DAM: Bloom contacted an attorney from Dempsey Law about reviewing the situation and provide the town legal advice. Motion by Elkins, second by Hurula to retain Dempsey Law to review the DOT proposal and advise the Town of its options. **CARRIED.** The board continued to discuss the options but will ultimately wait to hear from Dempsey Law before taking any action.

BILLS: Motion by Elkins, second by Hurula to approve checks #43975 through #44028 including debits and e-pays for payment of bills. **CARRIED.**
