**MONTHLY TOWN BOARD MEETING:** June 15, 2021.

**CALL TO ORDER:** 6:30 p.m. in the Civic Center by Roy Bloom, Chair.

**ATTENDANCE:** Roy Bloom, Chair; Chris Elkins, Supervisor; Jeff Hurula, Supervisor; Diane Gehr, Treasurer; Andy Tuttle, Clerk; Mark Jerome, Public Works Director; Three member of the public.

**MINUTES:** Motion by Elkins, second by Hurula to approve the minutes of the May 11, 2021 and May 25, 2021 town board meetings. **CARRIED.**

**TREASURER'S REPORT:** Gehr reported the following balances are in town accounts: Checking \$137,456.04, Savings \$354.36, Tax savings \$494,735.11, and LGIP \$124,879.99.

**ROAD REPORT:** Jerome reported:

- Wilkinson Rd, Hazelnut Rd, and Scrub Oak Rd are all prepped for gravel.
- The west end of Pigeon Lake Rd is back open.

**PUBLIC COMMENT:** None

**LIQUOR LICENSE RENEWALS:** Motion by Hurula, second by Elkins to approve liquor license renewals for Otter Bay Resort & Motel, Bear Country Convenience Store, Black Bear Inn, and KD's Bear Den. **CARRIED.**

**OPERATOR/BARTENDER LICENSES:** Motion by Hurula, second Elkins to grant operator/bartender licenses to Ben Wallin, Martin Nienajadlo, Joan Nienajadlo, Krista Love, Addie Arens, Zack Larson, and Krystal Hagstrom. **CARRIED.** One application was denied due to an unfavorable criminal record background check.

**CABLE AREA CHAMBER MEMBERSHIP:** The Cable Chamber has new membership levels. The board discussed the options and agreed to sign up the Drummond Lake Campground under the Gold membership level.

**PAVILION FLOOR REPAIR:** The pavilion floor has been heaving to the point it is unsightly and nearly unusable. The board discussed options for repair. Removing the wood floor and replacing with compacted recycled asphalt was preferred. The board also agreed remove the kitchen would also be appropriate. Mark will follow up and get estimates for further discussion.

**DELTA-DRUMMOND ROAD DAMAGE:** During the 90 degree weather days, over 200 loads of asphalt were hauled down Delta-Drummond Rd. This excess trucking combined with the high heat caused the new chip seal to pull loose from the asphalt. The board discussed who would be responsible for the repair work. The board would like to get estimates and approach the hauling company to see if they would be willing to pick up a portion of the cost.

BILLS: Motion by Elkins, second by Hurula to approve checks #434507 through #43574 including debits and e-pays for payment of bills. CARRIED.
