MONTHLY TOWN BOARD MEETING: June 15, 2021.

CALL TO ORDER: 6:30 p.m. in the Civic Center by Roy Bloom, Chair.

ATTENDANCE: Roy Bloom, Chair; Chris Elkins, Supervisor; Jeff Hurula, Supervisor; Diane Gehr, Treasurer; Andy Tuttle, Clerk; Mark Jerome, Public Works Director; 7 members of the public.

MINUTES: Motion by Elkins, second by Hurula to approve the minutes of the June 15, 2021 town board meeting. CARRIED.

TREASURER'S REPORT: Gehr reported the following balances are in town accounts: Checking \$204998.44, Savings \$354.38, Tax savings \$494,765.95, and LGIP \$124,884.48.

ROAD REPORT: Jerome reported:

- He is looking into rates to rent a second boom brusher, so they can get 2 machines working and get caught up.
- The estimate to level the floor in the pavilion would be around \$30,000. It may be cheaper to consider a new building. He will continue to research options.
- The campground expansion is going to require approximately 1300 yard of fill. Contracting for the materials and excavating work should fall within budget.
- The North Country Trail expansion into the village was approved by the USFS. Drummond can now consider being a "trail town".
- No estimate yet for repairs necessary to Delta-Drummond road.

PUBLIC COMMENT: Tom Johnson and several members of the Lake Owen Association voiced concerns over the increased property tax bills from last year and were looking for an explanation of what to expect for the upcoming year. They also asked the board to look into bonding for upcoming capital purchases.

OPERATOR/BARTENDER LICENSE APPEAL: This item tables since the concerned party was not in attendance.

SPEED ZONE REQUEST: The clerk received a request to lower the speed limit on Pioneer Road near Lake Tahkodah. A formal request should be forthcoming to be addressed at a future meeting.

ZONING REQUEST: Timothy & Connie DeChant have requested to have a residence in a parcel zoned commercial at 14690 Cty Hwy N. The property is being sold and the new buyers will not be operating the bed and breakfast and will be using the existing building as a residence. Motion by Hurula, second by

Elkins to recommend approval of the request to Bayfield County Planning & Zoning. CARRIED.

ZONING REQUEST: Delbert Jerome has requested to renew the permit for a non-metallic mine (sand & gravel pit) at 9285/9287 Cty Hwy N. A reclamation plan has been submitted to Bayfield County Planning & Zoning. Motion by Hurula, second by Elkins to recommend approval of the request to Bayfield County Planning & Zoning. CARRIED.

BILLS: Motion by Elkins, second by Hurula to approve checks #434575 through #43631 including debits and e-pays for payment of bills. CARRIED.
