MONTHLY TOWN BOARD MEETING: October 19, 2021.

CALL TO ORDER: 7:17 p.m. in the Civic Center by Roy Bloom, Chair.

ATTENDANCE: Roy Bloom, Chair; Chris Elkins, Supervisor; Jeff Hurula, Supervisor; Diane Gehr, Treasurer; Andy Tuttle, Clerk; Mark Jerome, Public Works Director; 2 members of the public.

MINUTES: Motion by Elkins, second by Hurula to approve the minutes of the October 19, 2021 and October 29, 2021 town board meetings. CARRIED.

TREASURER'S REPORT: Gehr reported the following balances are in town accounts: Checking \$567,247.57, Savings \$354.40, Tax savings \$,293.07, and LGIP \$124,905.31.76.

ROAD REPORT: Jerome reported:

- Plows have been hooked up and they are ready to go for the winter weather.
- Dead trees in the right-of-way are being cut.
- The crew is working on roadside brushing until snow.
- Bids have been let out for the truck body build for the new plow truck. Bids are due Dec. 10th and will be awarded at the Dec. town board meeting.
- He has met with an engineering firm about an elevation survey of campground and park that will be necessary for installation of utilities for the campground expansion.
- During recent activity at the Drummond Lake dam it was noted that there were several repairs necessary.

PUBLIC COMMENT: There was no public comment.

- COMPACTOR PROPOSAL: Jim Whittinghill, representative from Republic Services, presented a proposal for the rental of a set of compactors for the "town dump". Compactors should save on cost and will be cleaner and more efficient. The compactor rental agreement is for 10 years. Motion by Hurula, second by Elkins to enter into a contract with Republic Services for the rental of 2 compactors. CARRIED.
- OPERATOR LICENSE: The clerk received a request for a liquor license. He competed a background check that was forwarded to the board. The background check showed several serious criminal violations. Based on the background check no license was granted.
- 2022 BUDGET: The board discussed the comments that were made during the budget public hearing and whether changes to the budget were warranted and/or

necessary. Motion by Elkins, second by Hurula to adopt the 2022 budget as had been presented. CARRIED.

BILLS: Motion by Hurula, second by Elkins to approve checks #43821 through #43792 including debits and e-pays for payment of bills. CARRIED.

NEXT MEETING DATE: The next Town Board meeting is scheduled for Friday, December 21, 2021 in the Civic Center at 6:30 pm.
