MONTHLY TOWN BOARD MEETING: November 15, 2022.

CALL TO ORDER: 6:30 p.m. in the Civic Center by Roy Bloom, Chair.

- ATTENDANCE: Roy Bloom, Chair; Jeff Hurula, Supervisor; Diane Gehr, Treasurer; Andy Tuttle, Clerk; Mark Jerome, Public Works Director; 8 members of the public.
- MINUTES: Motion by Hurula, second by Bloom to approve the minutes of the October 11, 2022 and October 17, 2022 town board meetings. CARRIED. Add Diane.
- TREASURER'S REPORT: Gehr reported the following balances are in town accounts: Checking \$528,621.25, Savings \$354.49, Tax savings \$714.25 and LGIP \$327,266.91

ROAD REPORT: Jerome reported:

- Everything right now is "business as usual", preparing for winter and snow plowing.
- PARK & REC REPORT: Tuttle reported that he had spoken with the engineer and landscape architect about park design. They will do soil borings this winter and move forward with preliminary designs.

PUBLIC COMMENT: No public comment.

- MILL POND DAM UPDATE: Dean Olson gave an update: No progress to report. Dean asked if the Town had made contact with the DOT. The clerk said the DOT had not responded, but that the Town needed something to request or negotiate. Blanket update requests to the DOT are not generating responses.
- KIMBALL ROAD SNOWMOBILE SPEED: Complaints from several residents on Kimball Road were received via email regarding the 35 mph speed limit being too high. They have asked it be reduced. Mark Jerome spoke with both Deputy Kistner and the snowmobile club and neither felt the speed limit was too high. Mark did say he would ultimately like the trail off the Town road but that required Forest Service action. Motion by Hurula, second by Elkins to reduce the snowmobile speed limit on Kimball Road to 20 mph. CARRIED.
- AIRPORT COMMISSION: Pat Rodgers is stepping down as Drummond's representative on the airport commission. The board discussed possible replacements and will talk with possible candidates.
- 2023 BUDGET: There were no comments during the public hearing. Motion by Elkins, second by Hurula to approve the 2023 budget. CARRIED.
- BILLS: Motion by Hurula, second by Bloom to approve checks #44472 through #44530 including debits and e-pays for payment of bills. CARRIED.
